FIRST AMENDMENT TO DECLARATION FOR

OAKRIDGE BUSINESS PARK COMMERCIAL CONDOMINIUM

AND CONDOMINIUM MAP

This First Amendment to Declaration for Oakridge Business Park Commercial Condominium and Condominium Map is approved and effective on December **2**4, 2019 by **Oakridge Innovation, LLC**, a Colorado limited liability company, by Statement of Conversion of Oakridge Innovation, LLLP, a Colorado limited liability limited partnership ("Declarant").

RECITALS

A. Oakridge Business Park Commercial Condominium is a Condominium created pursuant to the Colorado Common Interest Ownership Act, C.R.S. § 38-33.3-101, et. seq., as it may be amended from time to time ("Act"), in which portions of the Property will be designated for separate or limited ownership and the remainder of which will be for common ownership solely by the Owners of the separate ownership interest. The Condominium is situated on and consists of the following described real property:

Amended Oakridge Business Park Commercial Condominium, Lot 1, Block 1, Oakridge Business Park 32nd Filing, situate in the Northeast Quarter of Section 6, Township 6 North, Range 68 West of the 6th P.M., City of Fort Collins, County of Larimer, State of Colorado.

- B. The above-described property is subject to the Declaration for Oakridge Business Park Commercial Condominium, which was recorded in the office of the Clerk and Recorder for Larimer County, State of Colorado, on September 18, 2019 at Recording No. 20190056364 (the "Declaration").
- C. The Condominium is described and depicted on the condominium map titled the "Amended Oakridge Business Park Commercial Condominium," which was recorded in the office of the Clerk and Recorder for Larimer County, State of Colorado, on September 18, 2019 at Recording No. 20190056453 (the "Condominium Map").
- D. In accordance with the provisions of Sections 14.2 and 14.3 of the Declaration, the Declarant, being the sole Unit Owner, hereby exercises its right to amend the Declaration and Condominium Map to the extent permitted by the Colorado Common Interest Ownership Act, C.R.S. § 38-33.3-101, *et seq.*, as amended, to make the Condominium Documents consistent with one another and the intent of the Declarant.

AMENDMENTS

- 1. The Condominium Map is hereby amended to delete all references to "limited common element" and "LCE" appearing therein.
- 2. The Condominium Map is hereby amended to substitute "common element" and "CE" in place of all references to "general common element" and "GCE" appearing therein.
 - 2. Section 1.10 of the Declaration is hereby amended as follows:
 - 1.10 *Common Element* shall mean and refer to all portions of the common interest community other than the Units including all real property, improvements, parking areas, drive aisles, sidewalks, and landscaping located outside the boundaries of the Condominium Units as depicted on the Condominium Map.
 - 3. Section 3.4 of the Declaration is hereby amended as follows:
 - 3.4 **Development**. Declarant has constructed the three (3) Buildings in the Condominium and has designated each of the Buildings, and portion of the real property and air space surrounding each of the Buildings, as a Condominium Unit. The location of each Building, the dimensions of the real property and air space surrounding each Building, and the boundaries for each Condominium Unit is shown on the Condominium Map or amended filings thereof.
 - 4. Section 15.2 *Enforcement by Governmental Entity* is deleted in its entity.
- 5. Except as provided herein, all of the terms and conditions of the Declaration and Condominium Map shall remain in full force and effect unless amended hereafter.
